1. The Ph.D in Law is of three-year (full-time) or five year (part-time) duration. Students may be registered as either a full or a part-time student. Students are expected to register every semester for their Ph.D. studies.

2. A full-time student is expected to accomplish his Ph.D. studies in three years. An extention of six months may be granted four times during the full-time Ph.D. programme, amounting to a total duration of five years.

3. However, if a student receives prior permission from the Deputy Vice Chancellor for Academic Affairs to withdraw or to be away from the university, and provided that the application in writing to withdraw or to be away from the university is submitted within the first two weeks of the academic year or semester, fifty percent of the fees may be refunded.

4. A part-time student is expected to accomplish his Ph.D. studies in five years. An extention of six months may be granted four times during the part-time Ph.D. programme, amounting to a total duration of seven years.

5. Tuition fees are payable in equal installments at the beginning of every semester.

5. Fees paid will not be refunded if a student withdraws or leaves the University without permission.
